



## **CHAIRMAN:**

CA S Chenthilkumar, Chairman and Independent Director chaired the meeting.

## Members present:

34 (Thirty four) members attended the meeting and there were 3 proxies.

At 03:00 PM, the Chairman commenced the proceedings of the meeting by welcoming the members to the 34<sup>th</sup> Annual General Meeting and informed that as per the provisions of Section 103 of the Companies Act, 2013 the requisite quorum was present and declared the meeting in order.

The Chairman then introduced the Directors and Senior Executives on the dias and also informed that the Register of Directors and Key Managerial Personnel and their shareholding maintained under Section 170, Register of Contracts or arrangements in which Directors are interested maintained under Section 189 along with other statutory registers under the Companies Act, 2013 along with other documents mentioned in the notice of the Annual











General Meeting and Proxy register were available for inspection by members at the venue during the meeting.

The Chairman further informed that the notice convening the 34<sup>th</sup> Annual General Meeting, audited financial statements and the directors' report were already circulated to the members along with the Annual Report and sought the permission of the members to treat them as read and the same was agreed by the members. The report of the Statutory Auditors and Secretarial Auditors did not contain any qualification / comments/ observations and the same was treated to be read as agreed by the members.

The Chairman delivered his speech on the financial performance of the Company.

Upon conclusion of his speech, he invited observations/ queries on the Company's operations and financial statements from the members. The Chairman, Managing Director, Executive Director and other senior executives answered the observations/ queries raised by the members satisfactorily and the Chairman thanked the shareholders for the active participation on behalf of the Company.

The Chairman further informed that pursuant to Section 108 of the Companies Act, 2013 read with Rule 20 & 21 of the Companies (Management and Administration) Rules, 2014 and Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company had engaged the services of Central Depository Services (India) Limited (CDSL) for the purpose of remote e-voting facility to members which commenced on 25<sup>th</sup> September, 2017 at 10:00 AM and concluded on 27<sup>th</sup> September, 2017 at 05:00 PM and Mr M Alagar, M/s Alagar& Associates, Practicing Company Secretaries, Chennai were appointed as Scrutinizers by the Board for scrutinizing the e-voting and polling. He further informed that the Company is also providing voting facility through poll for the members who have not cast their votes through the said e-voting facility.
