As per Section 108 of the Companies Act, 2013 read with the Rule 20 of the Companies (Management and Administration) Rules, 2014, and Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company is pleased to provide its members the facility to cast their votes by electronic means in respect of the business set forth in the Notice, through electronic voting ("remote e-Voting") facility extended by Central Depository Securities Limited (CDSL). The Board of Directors of the Company has fixed Thursday, 22nd September, 2016 as the cut-off date to record the entitlement of the members to cast their votes through remote e-Voting or the Ballot Paper at the AGM. A person, whose name is recorded in the Register of Members or in the Register of Beneficial Owners maintained by the Depositories as on the cut-off date i.e Thursday, 22nd September, 2016, shall only be entitled to avail facility of remote e-Voting or Ballot Paper at the AGM.
